**This Amendment** ("Amendment"), effective as of October 1, 2018, to the Defense Products Contract No. 46000000-15-1 ("Contract" or "STC"), is between the State of Florida, Department of Management Services ("Department") and Lou's Police Distributors, Inc. ("Contractor"), collectively referred to herein as the "Parties." All capitalized terms used herein shall have the meaning assigned to them in the STC unless otherwise defined herein.

**WHEREAS**, on October 1, 2015, the Department entered into an STC with Lou's Police Distributors, Inc. for the provision of Defense Products; and,

**WHEREAS**, the Parties agreed that the STC may be amended by mutual agreement as provided in section 42 ("Modification of Terms") of the General Contract Conditions incorporated into the STC; and,

**WHEREAS**, the Parties agree to renew the STC; and,

**THEREFORE**, in consideration of the mutual promises contained below, and other good and valuable consideration, receipt, and sufficiency of which are hereby acknowledged, the Parties agree to the following:

- I. **Contract Renewal.** Pursuant to section 2.2 ("Renewal") of the Special Contract Conditions, the STC is hereby renewed for a period of three (3) years, with a new contract expiration date of September 30, 2021, under the same terms and conditions.
- II. **Conflict.** To the extent any of the terms of this Amendment conflict with the terms of the STC, the terms of this Amendment shall control.
- III. **Warrant of Authority.** Each person signing this Amendment warrants that he or she is duly authorized to do so and to bind the respective Party.
- IV. **Effect.** Unless as otherwise modified by this Amendment, all terms and conditions contained in the STC shall continue in full force and effect.
