



**AMENDMENT NO.: 2**

Contract Extension

Contract No.: 405-200-13-1

Contract Name: Liquefied Petroleum Gas

**This Amendment** (“Amendment”), to the Liquefied Petroleum Gas Contract No.: 405-200-13-1 (“Contract”), between the State of Florida, Department of Management Services (“Department”) and Ferrellgas (“Contractor”), collectively referred to herein as the “Parties,” is effective on the last date signed by both parties. All capitalized terms used herein shall have the meaning assigned to them in the Contract unless otherwise defined herein.

**WHEREAS**, the Department awarded the above referenced Contract to Ferrellgas for the provision of Liquefied Petroleum Gas; and

**WHEREAS**, the Parties agreed that the Contract may be amended by mutual agreement as provided in section 42 of PUR 1000 “Modification of Terms” of the Contract; and

**WHEREAS**, in accordance with Section 287.057(12), Florida Statutes, upon mutual agreement, the Department and the Contractor wish to extend the Contract for a period that may not exceed six (6) months.

**THEREFORE**, in consideration of the mutual promises contained below, and other good and valuable consideration, receipt, and sufficiency of which are hereby acknowledged, the Parties agree to the following:

**I. Contract Extension.** The Contract shall be extended for an additional six (6) months, through October 29, 2019, unless cancelled or terminated as provided in the terms of the Contract.

**II. Conflict.** To the extent any of the terms of this Amendment conflict with the terms of the Contract, the terms of this Amendment shall control.

**III. Warrant of Authority.** Each person signing this Amendment warrants that he or she is duly authorized to do so and to bind the respective party.



**IV. Effect.** This Amendment is hereby made a part of the Contract. Unless otherwise modified by this Amendment, all terms and conditions contained in the Contract shall continue in full force and effect. This Amendment sets forth the entire understanding between the parties with regard to this subject matter hereof.
