THIS AMENDMENT No. 3 TO MICROSOFT SERVICES AGREEMENT – STATE AND LOCAL (NON-STANDARD) (the "Amendment") is made and entered into effective as of February 28, 2013 by and between the undersigned for the purpose of amending the Microsoft Services Agreement #U6914902 (also referred to as DR-001-FL) (State and Local – Non-Standard) incorporated in Florida State Term Contract 252-001-09-1 (the "Agreement" or "Contract"), effective as of January 4, 2001, by and between the State of Florida, Department of Management Services (the "State" or "you") and Microsoft Corporation ("Microsoft" or "Contractor").

Capitalized terms used herein and not otherwise defined have the meanings set forth in the Agreement.

In consideration of the promises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the State and Microsoft agree as follows:

#### I. Amendment.

1. Section 6, <u>Term and Termination</u>, is hereby revised to change the first sentence to read as follows:

"6. Term and Termination. This Agreement will continue and remain in effect until March 31, 2015, unless terminated (i) by mutual written agreement, or (ii) as otherwise set forth in this Section 6."

#### II. Fixed Price Contracts.

The following provision is hereby added to Section 10, <u>Additional Conditions</u>, and shall be included in the pricing section all Fixed Price Work Orders:
