**This Amendment** (“Amendment”), effective as of May 3, 2020, to the Pest Control Services Contract, No. 72102103-15-1 (“Contract”), is made by and between the State of Florida, Department of Management Services (“Department”), and Florida Pest Control & Chemical Co. (“Contractor”), collectively referred to herein as the “Parties.” All capitalized terms used herein have the meanings assigned to them in the Contract unless otherwise defined herein.

**WHEREAS**, the Department awarded the above-referenced Contract to the Contractor for the provision of pest control services;

**WHEREAS**, pursuant to Section 42 of the Contract’s Attachment IV, the Contract may be amended by mutual agreement; and

**WHEREAS**, the Parties wish to renew the Contract as provided in Section 1.4 of the Contract’s Attachment I and to amend the Contract to comply with statutory requirements.

**THEREFORE**, in consideration of the mutual promises contained below, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree to the following:

**I. Contract Renewal.** Pursuant to Section 1.4 of the Contract’s Attachment I, the Contract is renewed for a period of five years, with a new contract expiration date of May 2, 2025. The Parties shall perform their respective duties during the renewal period pursuant to the same terms and conditions provided in the Contract, as amended herein.

**II. Scrutinized Companies.** By entering into this Amendment, the Contractor certifies that: 1) it is not on the Scrutinized Companies with Activities in Sudan List or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List; and 2) it does not have business operations in Cuba or Syria. Section A of the Contract is also amended to add the following:

3. The Department may, at its option, terminate the Contract if the Contractor: is found to have submitted a false certification required by section 287.135(5), F.S.; has been placed on the Scrutinized Companies with Activities in Sudan List, the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List, or the Scrutinized Companies that Boycott Israel List; has been engaged in business operations in Cuba or Syria; or is engaged in a boycott of Israel.

**III. Conflict.** To the extent any of the terms of this Amendment conflict with the terms of the Contract, the terms of this Amendment will control.
