WHEREAS, the Department on July 1, 2016, executed the ACS Agreement authorizing the purchase of Equipment Maintenance Management Services from Specialty Underwriters, LLC under the State of Iowa Master Agreement No. MA# 005 3890-16, effective July 1, 2016 through June 30, 2017; and,

WHEREAS, the State of Iowa and Specialty Underwriters, LLC., have agreed that the Master Agreement may be renewed over a period of five (5) years through June 30, 2022, in one (1) year intervals; and,

WHEREAS, the State of Iowa and Specialty Underwriters, LLC., have renewed the Master Agreement through June 30, 2021; and,

WHEREAS, Amendment No. 1 was agreed to by both Parties and renewed Contract No. 72154066-ACS-15-1, effective July 1, 2017 through June 30, 2018; and,

WHEREAS, Amendment No. 2 was agreed to by both Parties and renewed Contract No. 72154066-ACS-15-1, effective July 1, 2018 through June 30, 2019; and,

WHEREAS, Amendment No. 3 was agreed to by both Parties and renewed Contract No. 72154066-ACS-15-1, effective July 1, 2019 through June 30, 2020; and,

WHEREAS, the Parties agreed that the ACS may be amended by mutual agreement as provided in section 6.9 ("Modification and Severability"), of the Special Contract Conditions, as incorporated into the ACS by Amendment No. 2; and,

WHEREAS, the Parties agreed the ACS may be renewed by mutual agreement as provided in subsection 2.2 ("Renewal") of the Special Contract Conditions incorporated into the ACS;

THEREFORE, in consideration of the mutual promises contained below, and other good and valuable consideration, receipt, and sufficiency of which are hereby acknowledged, the Parties agree to the following:
