**This Amendment No. 2** ("Amendment") to Contract No. 90121702-20-ACS, On-Demand Remote Interpreting and Document Translation ("Contract"), is entered into between the State of Florida, Department of Management Services ("Department"), and Corporate Translation Services, Inc. ("Contractor"), collectively referred to herein as the "Parties."

**WHEREAS**, the Department entered into the Contract with the Contractor on April 8, 2020, for the provision of On-Demand Remote Interpreting and Document Translation;

**WHEREAS**, the Contractor's name as listed in the Contract must be amended to reflect the Contractor's registered corporation name listed as active with the Florida Department of State, Division of Corporations;

**WHEREAS**, the Contract may be amended by mutual agreement as provided in Section 6.9, Modifications and Severability, of Exhibit B, Special Contract Conditions, of the Contract; and

**WHEREAS**, this Amendment reflects the modification of the Contractor's name only; all rights and obligations under this Contract shall remain, and Corporate Translation Services, LLC, agrees to perform all contractual responsibilities.

**THEREFORE**, in consideration of the mutual promises contained below, and other good and valuable consideration, receipt, and sufficiency of which are hereby acknowledged, the Parties agree to the following:

**I. Recitals.** The above recitals are hereby incorporated into this Amendment.


**II. Contractor.** Following the effective date of this Amendment, the term "Contractor" as used in the Contract shall refer to Corporate Translation Services, LLC. Corporate Translation Services, LLC, agrees to be bound by and fully perform all obligations, duties, and responsibilities, and to abide by all terms and conditions specified in the Contract as awarded to Corporate Translation Services, Inc.

**III. Conflict.** To the extent any of the terms of this Amendment conflict with any other terms of the Contract, the terms of this Amendment shall control.

**IV. Warranty of Authority.** Each person signing this Amendment warrants that he or she is duly authorized to do so and to bind the respective party.

**V. Effect.** Unless otherwise modified by this Amendment, all terms and conditions contained in the Contract shall continue in full force and effect. The effective date of this Amendment shall be the date of the final signature to this Amendment.


