Contract Title: Management Consulting Services

This Amendment No. 1 ("Amendment") to the Management Consulting Services Contract, No. 80101500-20-1 ("Contract"), is entered into between the State of Florida, Department of Management Services ("Department"), and CSRS, Inc. ("Contractor"), collectively referred to herein as the "Parties."

WHEREAS, the Department entered into the Contract with the Contractor for the provision of management consulting services, effective March 1, 2021;

WHEREAS, the Contractor's name as listed in the Contract must be amended to reflect the Contractor's registered corporation name listed as active with the Florida Department of State, Division of Corporations;

WHEREAS, the Contract may be amended by mutual agreement as provided in Section 6.9, Modification and Severability, of Contract Attachment B, Special Contract Conditions; and

WHEREAS, this Amendment reflects the modification of the Contractor's name only; all rights and obligations under the Contract shall remain, and CSRS, LLC, agrees to perform all contractual responsibilities.

THEREFORE, in consideration of the mutual promises contained below, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree to the following:

I. Recitals. The above recitals are hereby incorporated into this Amendment.

II. Contract. The term "Contract," as used herein, includes any purchase orders made pursuant to the Contract, either before or after the effective date of this Amendment.


III. Contractor. Following the effective date of this Amendment, the term "Contractor" as used in the Contract shall refer to CSRS, LLC. CSRS, LLC, agrees to be bound by and fully perform all obligations, duties, and responsibilities, and to abide by all terms and conditions specified in the Contract as awarded to CSRS, Inc.

IV. Conflict. To the extent any of the terms of this Amendment conflict with any terms of the Contract, the terms of this Amendment shall control.

V. Warranty of Authority. Each person signing this Amendment warrants that he or she is duly authorized to do so and to bind the respective party.

VI. Effect. Unless otherwise modified by this Amendment, all terms and conditions contained in the Contract shall continue in full force and effect. The effective date of this Amendment shall be the date of the final signature to this Amendment.
