This Amendment to Alternate Contract Source No. 81141902-VITA-18-ACS (“Contract” or “ACS”) to the State of Virginia Master Agreement No. VA-180315-GARG (“Master Agreement”) is made by the State of Florida, Department of Management Services (“Department”) and Gartner Inc. (“Contractor”), with its principal place of business located at 12600 GATEWAY BOULEVARD, FORT MYERS, FL 33913 collectively referred to herein as the “Parties.”

WHEREAS the Parties entered into the Contract which became effective on May 1, 2018 for the provision of IT Research and Advisory Services;

WHEREAS, the Contract was subsequently amended to expire on March 13, 2023, in correlation with the term of the Master Agreement;

WHEREAS, the Master Agreement term has since been amended to expire on March 13, 2024;

WHEREAS, the Parties agreed that the ACS may be amended by written mutual agreement as provided in Section 3, Modifications or Additions to Master Agreement, of the ACS; and

WHEREAS the Secretary has reevaluated the Master Agreement and determined that use of the Master Agreement remains cost-effective and the best value to the state;

ACCORDINGLY, and in consideration of the mutual promises contained in the Contract documents, the Parties agree as follows:

I. Contract Amendment. The Contract is amended to reflect a new expiration date of March 13, 2024.

II. Warranty of Authority. Each person signing this Amendment warrants that he or she is duly authorized to do so and to bind the respective party.

III. Conflict. To the extent any of the terms of this Amendment conflict with the terms of the Contract, the terms of this Amendment shall control.

IV. Effect. Unless otherwise modified by this Amendment, all terms and conditions contained in the Contract shall continue in full force and effect. This Amendment is effective when signed by both Parties.
