Contract Name: Technology Products, Services, Solutions, and Related Products and Services

**This Contract Amendment** to Contract No. 43210000-US-16-ACS (“Contract”) is made by the State of Florida, Department of Management Services (“Department”) and UNICOM Government, Inc. (“Contractor”), with its principal place of business located at 15010 Conference Center Drive, Suite 110, Chantilly, Virginia, 20151, collectively referred to herein as the “Parties.”

**WHEREAS**, the Parties entered into the Contract which became effective on May 1, 2016, to April 30, 2019, for the provision of Technology Products, Services, Solutions, and related Products and Services, pursuant to State of Virginia (Fairfax County) Master Agreement No. 4400006644 (“Master Agreement”);

**WHEREAS**, The Master Agreement was renewed for two (2) years through April 2021; and

**WHEREAS**, the Parties amended the Contract term to extend through April 30, 2021; and

**WHEREAS**, subsequently the Master Agreement was renewed for an additional one (1) year through April 30, 2022; and

**WHEREAS**, subsequently the Parties executed a new Participating Addendum which became effective on August 11, 2021, with a term ending April 30 2022; and

**WHEREAS**, subsequently the Master Agreement was renewed for an additional one (1) year through April 30, 2023; and

**WHEREAS**, the State of Virginia, Fairfax County and Contractor amended the Master Agreement term to extend through October 31, 2023; and

**WHEREAS**, the Department has evaluated the Contract and determined that continuation of the Contract is cost-effective and in the best interest of the state; and

**WHEREAS**, the Parties agree that the Contract may be amended by mutual agreement as provided in section 6.9, Modification and Severability, of Special Contract Conditions incorporated into the Contract in Exhibit C; and

**ACCORDINGLY**, and in consideration of the mutual promises contained in the Contract documents, the Parties agree as follows:

**I. Contract Extension.** The Contract is amended to extend the Term for a period of five (5) months, pursuant to the same terms and conditions except as amended herein, with a new Contract expiration date of October 31, 2023.
