

**AMENDMENT NO. 10 TO CONTRACT NO. DMS-14/15-018  
BETWEEN  
DEPARTMENT OF MANAGEMENT SERVICES  
AND  
SUN LIFE ASSURANCE COMPANY OF CANADA**

This Amendment to Contract No. DMS-14/15-018 (the "Contract") is by and between the State of Florida acting through the Department of Management Services (the "Department") and Sun Life Assurance Company of Canada ("Service Provider" or "Vendor"), collectively known as the "Parties."

**WHEREAS**, the Department, pursuant to section 110.123(3)(h)8.a., Florida Statutes, entered into the Contract with the Service Provider for Group Dental Benefits Insurance (Services), effective January 1, 2015;

**WHEREAS**, the Parties agreed the Contract may be amended by mutual agreement as provided in section 11.21, Modification of Terms;

**WHEREAS**, the Parties executed Amendment No. 1, effective January 1, 2016, which renewed the Contract for one (1) year;

**WHEREAS**, the Parties executed Amendment Nos. 2 and 3, effective January 1, 2017, and July 1, 2017, respectively, which each extended the Contract for six (6) months;

**WHEREAS**, the Parties executed Amendment Nos. 4 and 5, effective January 1, 2018, and January 1, 2019, respectively, which each extended the Contract for one (1) year;

**WHEREAS**, the Parties executed Amendment No. 6, effective January 1, 2020, which assigned all Contract rights and obligations to Sun Life Assurance Company of Canada;

**WHEREAS**, the Parties executed Amendment No. 7, effective January 1, 2020, which extended the Contract for one (1) year;

**WHEREAS**, the Parties executed Amendment Nos. 8 and 9, effective January 1, 2021, and January 1, 2022, respectively, which each extended the Contract for one (1) year; and

**WHEREAS**, the Parties wish to amend the Contract as set forth herein.


**NOW THEREFORE**, in consideration of the mutual promises contained herein and other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Parties agree the Contract shall be amended as follows:

1. The terms and conditions of the Contract, as previously amended ("Amended Contract"), are incorporated by reference as if fully re-written herein. Except as expressly amended and supplemented by this Amendment, the terms and conditions of the Amended Contract will remain in effect unchanged. If and to the extent that any inconsistency may appear between the Amended Contract and this Amendment, the provisions of this Amendment shall control.
2. Extension Term. The Department hereby extends the Contract effective **January 1, 2023**, until **December 31, 2023**. This Contract Extension will be in effect with no plan or premium changes for or during the Contract Extension Term.
3. Premium Rates. The monthly premium rates during the Extension Term remain unchanged from the Contract.




