Contract Title: Information Technology Staff Augmentation

This Amendment (“Amendment”) to the Information Technology Staff Augmentation 80101507-22-STC-ITSA (“Contract”), is entered into between the State of Florida, Department of Management Services (“Department”) and Apex Systems, Inc (“Contractor”), collectively referred to herein as the “Parties.”

WHEREAS, the Department entered into a Contract with Apex Systems, Inc on November 14, 2022 for the provisions of Information Technology Staff Augmentation Services.

WHEREAS, the Contractor’s name as listed in the Contract must be amended to reflect the Contractor’s registered corporation name listed as active with the Florida Department of State Division of Corporations; and

WHEREAS, the Parties agreed that the Contract may be amended by mutual agreement as provided in section II Contract of the Contract.

WHEREAS, this Amendment reflects the modification of the Contractor’s name only. All rights and obligations under this Contract shall remain and Apex Systems, LLC agrees to perform all Contractual responsibilities.

THEREFORE, in consideration of the mutual promises contained below, and other good and valuable consideration, receipt, and sufficiency of which are hereby acknowledged, the Parties agree to the following:

I. Recitals. The above recitals are hereby incorporated into this Amendment.

II. Contract. The “Contract”, as used herein, whether capitalized or not, means the Contract for Information Technology Staff Augmentation (Contract No. 80101507-22-STC-ITSA, including any amendments or modifications to such Contract; and any purchase orders made pursuant to the Contract, either before or after the effective date of this Agreement.

III. Contractor. Following the effective date of this Amendment, the term “Contractor” as used in the Contract shall refer to Apex Systems, LLC. Apex Systems, LLC agrees to be bound by and fully perform all obligations, duties, and responsibilities, and to abide by all terms and conditions specified in the Contract as awarded to Apex Systems, Inc.


IV. Conflict. To the extent any of the terms of this Amendment conflict with any other terms of the Contract, the terms of this Amendment shall control.


V. Warranty of Authority. Each person signing this Amendment warrants that he or she is duly authorized to do so and to bind the respective party.
