



CONTRACT AMENDMENT NO. 1

Contract Name: Information Technology Staff Augmentation

This Amendment No. 1 (Amendment) to Contract No. 80101507-22-STC-ITSA (“Contract”), effective as of the date last signed below, is made by and between the Department of Management Services (“Department”), an agency of the state of Florida (State), located at 4050 Esplanade Way, Tallahassee, Florida 32399, and Vinali LLC dba Vinali Staffing (“Contractor”), collectively referred to herein as the “Parties.”

WHEREAS, the Department, pursuant to an Invitation to Bid (ITB) 22-80101507-ITB, “Information Technology Staff Augmentation,” the Parties entered into the Contract which became effective on October 11, 2022, or on the last date the Contract was signed by the Parties, for the provision of Information Technology Staff Augmentation Services.

WHEREAS, the Parties agreed that the Contract may be amended by mutual agreement as provided in Exhibit C, Special Contract Conditions (Florida), subsection 6.9, Modification and Severability, and;

NOW THEREFORE, in consideration of the mutual promises contained herein and other good and value consideration, the receipt and adequacy of which are hereby acknowledged, the Parties agree as follows:


- I. The terms and conditions of the Contract are incorporated by reference as if fully re-written herein. Except as expressly amended and supplemented by this Amendment, the terms and conditions of the Contract will remain in effect unchanged.
- II. The Contract is amended to modify the expiration date for a period of three months pursuant to the same terms and conditions, with a new Contract expiration date of December 31, 2023.
- III. **Warranty of Authority.** Each person signing this Amendment warrants that he or she is duly authorized to do so and to bind the respective party.
- IV. **Conflict.** To the extent any of the terms of this Amendment conflict with the terms of the Contract, the terms of this Amendment shall control.


