**SCOPE OF WORK**: The Holiday Shores Phase 1A Pedestrian and Drainage Improvements project is located along Forest Shore Drive and Shore Drive, north of US Hwy 98, in Miramar Beach, Florida. Phase1 of this project includes the construction of an 8' wide concrete sidewalk within the Forest Shore Drive right-of-way beginning at US Hwy 98 and terminating at Shore Drive. In conjunction with the pedestrian improvements, Forest Shore drive will be milled, resurfaced, and restriped within the project limits. Minor earthwork, swale construction, storm drain installation, and sodding will be required within the right of way limits.
