Tracking Participation

DMS will track participation by certified and non-certified woman-, veteran-, and minorityowned businesses by reviewing the Florida Accounting and Information Resource (FLAIR) and by reviewing contractor and subcontractor responses to competitive and non-competitive solicitations.

Programs, Initiatives, and Outreach

The DMS Bureau of Departmental Purchasing will encourage increased participation from State of Florida certified and non-certified woman-, veteran- and minority-owned businesses by continuing to do the following:

- Ensure that competitive solicitations are written to remove barriers for State of Florida certified and non-certified woman-, veteran- or minority-owned businesses.
- Publish content on the DMS website that includes information on how to register as a State of Florida certified or non-certified women-, veteran- or minority-owned businesses with OSD.
- Incorporate supplier diversity information into the policies and procedures of the Bureau of Departmental Purchasing.
- Provide informational notices of competitive and non-competitive solicitations on the Vendor Information Portal.

Proposed Outreach Activities

The DMS website will continue to provide vendors the most current information on state spending and vendor requirements. The OSD page is at the following link: https://www.dms.myflorida.com/agency_administration/agency_purchasing

DMS outreach activities present opportunities to provide general education on the commitment of the agency to small businesses. These outreach efforts include participation in OSD Supplier Diversity Exchange events. The Bureau of Departmental Purchasing will encourage DMS staff to include randomly-selected vendors when requesting quotes and will participate in future local OSD Supplier Diversity Exchange events, encouraging OSD-certified businesses to attend.

Planned Education

Educational activities within the Bureau of Departmental Purchasing include the following:

- Promoting inclusive business utilization.
- Informing businesses of DMS' spend plan, including anticipated procurement opportunities.
- Encouraging vendors to view the information OSD has posted on the DMS website.
- Encouraging non-certified businesses to become certified through OSD.

New Initiatives and Internal Procedures

DMS is always seeking new, innovative ways to improve our business practices and gain efficiencies while serving our vendor community. In FY 2023-2024, the Bureau of Departmental Purchasing will increase awareness of opportunities for OSD-certified businesses through MyFloridaMarketplace and the Vendor Information portal.

Plan Incorporating the Use of Quotes to Improve Opportunities

The Bureau of Departmental Purchasing will continue to review quoting opportunities to determine the viability of receiving more quotes from certified and non-certified minority-owned businesses.
