

## AMENDMENT NO.: 3 Contract No.: 22100000-21-STC Contract Title: Construction and Industrial Equipment

**This Amendment** ("Amendment") to Construction and Industrial Equipment 22100000-21-STC ("Contract"), effective as of the date last signed below, is entered into between the State of Florida, Department of Management Services ("Department") and Clark Equipment Company ("Contractor"), collectively referred to herein as the "Parties."

**WHEREAS** the Department entered into a Contract with Clark Equipment Company on June 2, 2021 for the provisions of construction and industrial equipment;

**WHEREAS** the Contractor's name as listed in the Contract must be amended to reflect the Contractor's registered corporation name listed as active with the Florida Department of State Division of Corporations;

**WHEREAS** the Parties agreed that the Contract may be amended by mutual agreement as provided in Attachment 1, Special Contract Conditions (Florida), subsection 6.9, Modification and Severability; and

**WHEREAS** this Amendment reflects the modification of the Contractor's name only, and all rights, obligations, duties, and responsibilities under this Contract shall remain the same.

**THEREFORE**, in consideration of the mutual promises contained below, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree to the following:

- **I. Contract.** The "Contract", as used herein, whether capitalized or not, means the Contract for Construction and Industrial Equipment (Contract No. 22100000-21-STC), including any amendments or modifications to such Contract; and any purchase orders made pursuant to the Contract, either before or after the effective date of this Amendment.
- **II.** Contractor. Following the effective date of this Amendment, the term "Contractor" as used in the Contract shall refer to Doosan Bobcat North America, Inc. dba Bobcat Company. Doosan Bobcat North America, Inc. dba Bobcat Company agrees to be bound by and fully perform all obligations, duties, and responsibilities, and to abide by all terms and conditions specified in the Contract as awarded to Clark Equipment Company.
- **III.** Conflict. To the extent any of the terms of this Amendment conflict with any other terms of the Contract, the terms of this Amendment shall control. All other terms of the Contract remain in full force and effect.
