Contract Title: Management Consulting Services

**This Amendment** ("Amendment") to Contract No. 80101500-20-1 ("Contract"), effective as of the date last signed below, is entered into between the State of Florida, Department of Management Services ("Department") and Atkins North America, Inc. ("Contractor"), collectively referred to herein as the "Parties."

**WHEREAS** the Department entered into a Contract with Atkins North America, Inc. on March 1, 2021 for the provisions of Management Consulting Services;

**WHEREAS**, the Contractor's name as listed in the Contract must be amended to reflect the Contractor's registered corporation name listed as active with the Florida Department of State Division of Corporations;

**WHEREAS** the Parties agreed that the Contract may be amended by mutual agreement as provided in Contract Attachment B, section 6.9 Modification and Severability; and

**WHEREAS** this Amendment reflects the modification of the Contractor's name only, all rights, obligations, duties, and responsibilities under this Contract shall remain the same.

**THEREFORE**, in consideration of the mutual promises contained below, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree to the following:

**I. Contract.** The "Contract", as used herein, whether capitalized or not, means the Contract for Management Consulting Services (Contract No. 80101500-20-1), including any amendments or modifications to such Contract; and any purchase orders made pursuant to the Contract, either before or after the effective date of this Amendment.




