**This Contract Amendment** to Contract No. 80101500-20-1 (“Contract”) is made by the State of Florida, Department of Management Services (“Department”) and Digital Intelligence Systems, LLC (“Contractor”), with its principal place of business located at 8270 GREENSBORO DRIVE, SUITE 1000, MCLEAN, VA 22102, collectively referred to herein as the “Parties.”

**WHEREAS** the Parties entered into the Contract which became effective on March 1, 2021 for the provision of Management Consulting Services;

**WHEREAS** the Contract was extended for a period of six months, with a new Contract expiration date of August 31, 2024 and;

**WHEREAS** the Contract was extended for a period of three months, with a new Contract expiration date of November 30, 2024, and;

**WHEREAS** the Parties agree to extend the Contract for six (6) months per s. 287.057(13), F.S.; and

**WHEREAS** the Parties agreed that the Contract may be amended by mutual agreement as provided in Attachment B, Special Contract Conditions (Florida), subsection 6.9, Modification and Severability.

**ACCORDINGLY**, and in consideration of the mutual promises contained in the Contract documents, the Parties agree as follows:

**I. Contract Extension.** The Contract is extended for a period of six (6) months pursuant to the same terms and conditions of the contract and any executed written amendments, with a new Contract expiration date of May 31, 2025.

**II. Warranty of Authority.** Each person signing this Amendment warrants that he or she is duly authorized to do so and to bind the respective party.

**III. Conflict.** To the extent any of the terms of this Amendment conflict with the terms of the Contract, the terms of this Amendment shall control.

**IV. Effect.** Unless otherwise modified by this Amendment, all terms and conditions contained in the Contract shall continue in full force and effect. This Amendment is effective when signed by both Parties.
